## SECOND AMENDMENT TO THE ARTICLES OF INCORPORATION AND BYLAWS OF BERMUDA DUNES PRIVATE RESIDENCES CONDOMINIUM ASSOCIATION, INC.

WHEREAS, the Articles of Incorporation of Bermuda Dunes Private Residences Condominium Association, Inc. (hereinafter "Articles") was recorded on March 27, 2006 in Official Records Book 8549, Page 344, Public Records of Orange County, Florida; and

WHEREAS, the Bylaws of Bermuda Dunes Private Residences Condominium Association, Inc. (hereinafter "Bylaws") was recorded on March 27, 2006 in Official Records Book 8549, Page 316, Public Records of Orange County, Florida; and

WHEREAS, the Articles and Bylaws were amended by the Amendment to the Articles of Incorporation and Bylaws of Bermuda Dunes Private Residences Condominium Association, Inc., recorded on September 17, 2008 in Official Records Book 9762, Page 4992, Public Records of Orange County, Florida; and

WHEREAS, pursuant to Article 13 of the Articles, the Articles may be amended by the affirmative vote of at least a majority of the Members of the Bermuda Dunes Condominium Association who are present at a duly noticed Members' meeting at which a quorum of the Members is present; and

WHEREAS, pursuant to Section 14.2(b) of the Bylaws, the Bylaws may be amended by not less than 80% of the votes of the members of the Association voting in person or by proxy at a meeting at which a quorum has been attained.

WHEREAS, on November 2, 2021, the Association held a duly noticed meeting of the Members at which 132 Members were present in person or by proxy, which constituted a quorum of the Members of the Association; and

WHEREAS, at the meeting 128 Members voted in favor of amending Article 10, Section 10.1 of the Articles of Incorporation and 4 Members voted against it; 128 Members voted in favor of amending Section 4.1 of the Bylaws and 4 Members voted against it; and

NOW, THEREFORE, the Articles of Incorporation of Bermuda Dunes Private Residences Condominium Association, Inc. is amended as follows to increase the number of directors from three to five:

Amending Article 10, Section 10.1 of the Articles of Incorporation to read as follows:

# Article 10 Directors

10.1 <u>Number and Qualification</u>. The property, business and affairs of the Association shall be managed by a board consisting of three (3) five (5) directors.

NOW, THEREFORE, the Bylaws of Bermuda Dunes Private Residences Condominium Association, Inc. is amended as follows to increase the number of directors from three to five:

## Amending Section 4.1 of the Bylaws to read as follows:

## 4. Directors

4.1 <u>Membership.</u> The affairs of the Association shall be governed by a Board consisting of three (3) five (5) directors.
